ORDINANCE CANCELLING \$808,773 OF OBLIGATIONS  
AUTHORIZED BUT NOT ISSUED FOR AND BY THE BOROUGH OF  
NEW PROVIDENCE, IN THE COUNTY OF UNION, NEW JERSEY

BE IT ORDAINED BY THE BOROUGH COUNCIL OF THE BOROUGH OF NEW PROVIDENCE, IN THE COUNTY OF UNION, NEW JERSEY (with not less than two-thirds of all members thereof affirmatively concurring), AS FOLLOWS:

Section 1. The Borough of New Providence, in the County of Union, New Jersey (the "Borough"), hereby cancels the aggregate amount of \$808,773 in bonds and bond anticipation notes previously authorized by the respective bond ordinances listed below, but not issued as of the date hereof, in the respective amounts set opposite each respective bond ordinance:

The Borough Chief Financial Officer is hereby authorized and directed to take any action necessary to effectuate the cancellation of the amounts set forth in Section 1 hereof, including make any adjustments to the Borough's gross and net debt as reflected on any annual or supplemental debt statement.

Section 3. The Borough hereby certifies that it has adopted a capital budget or a temporary capital budget, as applicable. The capital or temporary capital budget of the Borough is hereby amended to conform with the provisions of this ordinance to the extent of any inconsistency herewith. To the extent that the purpose authorized herein is inconsistent with the adopted capital or temporary capital budget, a revised capital or temporary capital budget has been filed with the Division of Local Government Services.

Section 4. This ordinance shall take effect 20 days after the first publication thereof after final adoption, as provided by law.
